## Terms of license granted by the author to the Polish Society of Internal Medicine (hereinafter referred to as 'the PSIM')

1. This document (hereinafter referred to as 'the License Terms') sets out the rights and obligations of the author who submits their work (hereinafter referred to as 'the Applicant') to the Editorial Board of *Polish Archives of Internal Medicine* (hereinafter referred to as 'the Editorial Board'), as well as the terms of the license granted by the Applicant to the PSIM.
2. For the purpose of these License Terms the Applicant's work (hereinafter referred to as 'the Work') shall be understood as all categories of articles submitted to the Editorial Board for publication in *Polish Archives of Internal Medicine*.
3. The Applicant must confirm the statements and warranties contained herein for the Editorial Board to commence any procedure in relation to the Work, including its review.
4. Upon confirming the warranties and approval of the License Terms (by ticking the appropriate box in the application form), acting on their own behalf and on behalf of other co-authors (if any and if entitled to do so), the Applicant hereby – **at their discretion** – grants:
  - A. a worldwide, free of charge, non-exclusive, irrevocable license to:
    - reproduce and share the Work, in whole or in part; and
    - produce, reproduce, and share derived works based on the Work (CC BY). For the avoidance of doubt, the Applicant acting on their own behalf (and of the other co-authors – if any and if entitled to do so) agrees to release the Work in an electronic form under a Creative Commons license (CC BY) under the terms described on the official Creative Commons website: <https://creativecommons.org/licenses/by/4.0/legalcode> and to mark the Work with the appropriate CC license notice (CC BY); if this license is selected, **paragraphs 11-14 of the License Terms do not apply**;

**or**

**B.** a worldwide, free of charge, non-exclusive, irrevocable license to:

- reproduce and share the Work, in whole or in part, for non-commercial purposes only; and
- produce, reproduce, and share derived works based on the Work for non-commercial purposes only

**(CC BY-NC-SA).** For the avoidance of doubt, the Applicant acting on their own behalf (and of the other co-authors – if any and if entitled to do so) agrees to release the Work in an electronic form under a Creative Commons license (CC BY-NC-SA) under the terms described on the official Creative Commons website: <https://creativecommons.org/licenses/by-nc/4.0/legalcode> and to mark the Work with the appropriate CC license notice (CC BY-NC-SA).

5. The Applicant declares that they are the author of the Work pursuant to the Polish Act on Copyright and Related Rights and have written the Work in person, therefore being its sole author. If, in addition to the Applicant, other persons participated in the creation of the Work, and as co-authors are jointly entitled to the copyright in the Work, the Applicant declares that they are authorized to submit the Work and to make all declarations as well as grant the license to use the Work for and on behalf of all other co-authors. In such a case, the Applicant is obliged to indicate all other co-authors to the Editorial Board, and if the contributions of individual co-creators in the Work are not equal, the Applicant is obliged, in agreement with the other co-authors, to indicate to the Editorial Board the individual contributions of all the co-authors involved.

6. If the Work has been written with the participation of contributors other than the Applicant, the Applicant makes all declarations, including declarations of will with reference to granting the license for and on behalf of all other co-authors and shall be liable for lack of authorization or an insufficient authorization.

7. The Applicant warrants that the Work was not sponsored or financed in any way or co-financed. If the Work has been subject to external financing, the Applicant is obliged to inform the Editorial Board about it and at the same time declare that the authors of the sponsored Work have not been subjected to any influence from the sponsors during the course of research and preparation of the Work. The Applicant is obliged to inform the PSIM of any potential conflict of interest, in particular, consisting in receiving the following from the company whose products are presented in the Work or from a company that produces competitive products: lecture fees, coverage of travel costs, research subsidies, or any consultation fees. If no conflict of interest is declared, the Applicant should include the following statement on the title page of the Work: 'Conflict of interest: none declared.' At the same time, the Applicant declares that the study protocol has been approved by the bioethics committee, if applicable.

8. The Applicant declares that the Work has been written with due diligence resulting from the professional nature of the author's activity and experience, taking into account current medical knowledge.

9. The Applicant declares that they (and any co-authors) hold all the copyright as well as all moral rights to the Work and that the Work does not infringe any:

- a) third party intellectual property rights;
- b) third party moral rights.

10. The Applicant declares that the Work has not been made available to the public before and has not been published in any form in any publication or magazine. At the same time, the Applicant declares that the Work has not been submitted for publication to any other publishing house or journal and that they will not submit it for publication or forward it for this purpose to any entity other than the PSIM until the Editorial Board issues a negative decision regarding publication of the Work in *Polish Archives of Internal Medicine* and informs the Applicant of such a decision.

11. Independently and separately from the open license (Creative Commons) granted pursuant to section 4B above, the Applicant, acting on the basis of Article 67 section 2 of the Polish Act on Copyright and Related Rights, upon confirming the warranties and approval of the License Terms (by ticking the appropriate box in the application form) grants the PSIM a free of charge, non-exclusive license to use the Work with no restriction as to a territory or term, in all the fields of exploitation known at the conclusion of this license agreement, including commercial purposes and those referred to in Article 50 of the Polish Act on Copyright and Related Rights, including but not limited to the following:

- a) within the scope of fixation and reproduction of the Work: the production of copies of the Work by way of using a specific technique, including printing, reprographic, magnetic storage, and digital technique,
- b) within the scope of trade of the original Work or the copies on which the Work was fixed: the distribution, gratuitous lending, or rental of the original or copies,
- c) introducing the Work into any computer memory,
- d) introducing the Work and making it available on the Internet, intranet, and other computer networks,
- e) public performance, display, and broadcast,
- f) broadcast of the Work by means of wired, wireless, and satellite networks,
- g) making the Work available to the public in a manner allowing every person to have access to the Work in a place and at a time of their own choice.

For the removal of doubts, the Applicant hereby declares that the granting of the aforementioned license to the PSIM to use the Work also for commercial purposes does not violate the terms of the open license referred to in paragraph 4B above, but only grants PSIM additional privileges.

12. Upon confirming the warranties and approval of the License Terms (by ticking the appropriate box in the application form, the Applicant grants the PSIM a free of charge permission to exercise and permit the exercise of derivative rights in the Work with no restriction as to a territory or term in all fields of exploitation indicated in section 11 above. The said permission includes the right to produce derived works based on the Work as well as the right to dispose of and use such derived works including but not limited to:

- a) making abbreviations, cuts, structural changes, and translations of the Work,
- b) modifying the entire Work and its individual fragments, including the right to edit, introduce corrections, changes, and to adapt the Work,
- c) combining the Work and its fragments with other works, including those that have not been created as a result of the activities of the Applicant.

The Applicant declares that such use of the Work does not violate the integrity of the Work and the right of fair use.

13. Within the scope of the rights granted herein to the PSIM, the rights referred to in section 12 above may be the object of further transfer for the purposes of publication of the Work in *Polish Archives of Internal Medicine* and making it available on the website on which *Polish Archives of Internal Medicine* is or will be published in the future in an electronic form. The rights granted hereby may be transferred onto other entities which will be entitled to the same. Within the scope of the rights granted herein, the PSIM is entitled to authorize third parties to produce derived works based on the Work and to transfer and use such derived works and to permit such third parties to grant further permissions in this respect.

14. The PSIM will be entitled, within the scope of the non-exclusive license granted pursuant to section 11 above, to authorize other entities to use the Work in all the fields of exploitation indicated in section 11 hereof (i.e. to grant sub-licenses), following which such entities will be authorized to grant further sub-licenses.

15. The Applicant acknowledges and agrees that the Work may be reviewed by an anonymous reviewer of the same specialization as the Applicant and undertakes to include such reviewer's comments within the time indicated by the Editorial Board under the pain of cancelling the publication. The Applicant further declares that they are aware that the Work will be subject to editing, as a result of which appropriate modifications may be made to it, to which the Applicant gives irrevocable and unlimited in time and territory consent (which may be transferred to third parties).

16. The Applicant acknowledges that the PSIM may not publish the Work, however, in the event of the approval of the Work for publication by the Editorial Board, they authorize the PSIM to make the Work available to the public for the first time.

17. The Applicant acknowledges and agrees that the Work – if published in *Polish Archives of Internal Medicine* – will be published upon payment of a current publication fee posted on the journal's website: <https://www.mp.pl/paim/for-authors>. The Applicant agrees that they will not demand any remuneration in connection with the conclusion, execution, or scope of this license agreement from the PSIM or any third parties using the Work.

18. The Applicant declares that in the case of publication of the Work in *Polish Archives of Internal Medicine* they agree to the Work being signed with their first and last name and agree to provide their specialization.

19. The Applicant undertakes to provide, upon the PSIM's request, necessary documentation confirming that they (and/or other co-authors indicated by them) hold copyrights and moral rights to the Work.

20. In the case of a third party claims against the PSIM related to the use of the Work by the PSIM or in the case of a third party filing for copyright infringement in connection with the Work, the Applicant undertakes to take all actions available to them to withdraw such claims against the PSIM, and – if this is not possible – to insure the PSIM against liability in relation to such third party claims (and in the course of possible court proceedings, to

join PSIM as an intervening party and actively participate in the proceedings in order to dismiss the third party's claims). In any case, the Applicant will be obliged to bear the costs of legal representation, court costs, and pay damages or cover the costs of an amicable settlement of the case.

21. The provisions of section 20 shall apply accordingly to the third parties who, within the limits of the PSIM license, grant a sub-license or permit to prepare derivative works based on the Work and have the right to dispose of and use the Work.

22. In matters not regulated in the License Terms, the relevant provisions of Polish law will apply – first of all, the Polish Act on Copyright and Related Rights, and in matters not regulated therein, the provisions of the Civil Code.

23. If any provision of the License Terms is invalid or ineffective with respect to a third party, the remaining provisions of the License Terms shall remain in force, with the exception of those provisions whose content - after excluding the invalid or ineffective provisions with respect to a third party - cannot be reasonably reconciled with the rest of the License Terms. The provisions of the License Terms that are invalid or ineffective with respect to a third party shall be replaced by valid and effective provisions, the content of which shall correspond as closely as possible to the original will of the Parties and the economic purpose of the License Terms. The above shall also apply in the event that any provision of the License Terms is partially invalid or ineffective with respect to a third party.
